

# **Synergetic Play Therapy Supervision and Consultation Application Requirements- Online Intro to SPT Consultation**

In order to apply to become a Consultant for the Online Intro to SPT course you must meet the following requirements. If you are interested, please send a one-page email to [info@playtherapycolorado.com](mailto:info@playtherapycolorado.com) and address the following:

## **Online Intro to SPT Consultation Requirements**

### **Consultant Requirements for Application:**

- Must be 2 years post SPT Certification or have 1 year supervisory experience with more than 2 supervisees and must have worked with clients regularly (5 a week minimum) during the year preceding application to become a consultant
- Must be an RPT-S or the equivalent in your country if not US based (If not US based, consultants assigned will be from same country)
- Must be current in their SPT Certification
- Must make a 2 year commitment to the Institute (4 rounds of Intro courses) and provide post course monthly supervision leading up to SPT Certification course for any of their supervisees that get accepted into the SPT Certification Program
- Must be willing to market the Institute and its programs separate from own practice or business- feel competent in sales and financial conversations
- Must be enrolled in the SPT Supervision course during first round or have already completed this course

### **Responsibilities:**

- Provide 60 minutes of consultation each month during the 6 month course to each of your consultees (~5-10 consultees depending on size of class)
- Watch the videos of the course/take the tests and follow along with your supervisees (After first course, only webinars are required)
- Scheduling and tracking all of your consultations
- Attend a 15 min. Consultant check-in meeting with Lead Consultant Supervisor each month
- Provide one hour of monthly supervision to consultees moving on to SPT Program to prepare them for the course and support the consultee in completing all of the pre-cert program requirements

Payment: \$70 per 1 hour of consultation, CE credits of the course, and fee and course completion waived for the staying current in SPT requirement. \$100 post course

supervision. \$25/hour admin for watching the webinars and attending mostly consultation check-ins. SPT Membership fee waived during duration of this contract.

For every 2 year renewal cycle, the hour for consultation increases.

2-4 years: 85.00 per hour

4-6 years: 100.00 per hour

### **SPT Intensive Training Supervisor Requirements Intensive Teaching/Supervisor Requirements for Application:**

- Must be willing to work for and represent the Play Therapy Institute of Colorado separate from own business or practice and feel competent in sales and financial conversation
- Must be a Certified SPT Supervisor and completed 1 year as an Intro to SPT Consultant
- Must demonstrate ability to teach The Set Up, The Curve, Process of Change, Nervous System and Brain, Emotional Stages, SPT on Attachment, Regulation, Parent Involvement, The Funnel, and feel knowledgeable to explore sand, art and aggression as they arise. To be demonstrated through video recording and submitted to Lisa.
- Must be willing to make a 2 year commitment to the Institute and teach a minimum of 2 Intensives per year.
- Must be willing to shadow and volunteer at an Intensive prior to teaching first intensive.
- Must be current in SPT Certification.
- Must have attended the Intensive as a participant or attend 2 Intensives as a volunteer supervisor

### **Responsibilities:**

- Supervisors will meet prior to the training and agree which parts each will teach
- All teaching must be in line and follow the general standards outlined and modeled by Lisa. The teaching must follow the Intensive Teaching Schedule
- If you teach, you are responsible for the quality and delivery of that information
- Observe all of your supervisee's sessions and provide 45 minutes of post session supervision
- Provide one hour of monthly supervision to consultees moving on to SPT Program to prepare them for the course and support the consultee in completing all of the pre-cert program requirements

Payment: \$2750 for 4 participants and \$2200 for 3 participants, plus CE Certificate. \$100 post Intensive supervision. SPT Membership fee free during duration of this contract.

### **SPT Certification Program Supervisor Requirements**

#### **Certification Program Supervisor Requirements for Application:**

- Must be willing to work for and represent the Play Therapy Institute of Colorado separate from own business or practice
- Must attend a Break Through Experience with Dr. John Demartini (or equivalent with Lisa)
- Must be a Certified SPT Supervisor
- Must have supervised at least four intensive trainings
- Must be willing to make a 2 year commitment to the Institute
- Must be current in SPT Certification

**Requirements:**

- Provide monthly one-hour supervision
- Track all supervisee homework assignments
- Attend retreats if possible and provide support during presentations and group supervision at each retreat- in person not mandatory, can be over computer
- Conduct two skill assessments during course on supervisees
- Attend classes
- Supervisor may be asked to attend a retreat in another state. Flight and hotel accommodations would be covered by PTIC.
- Support students in completing their program requirements
- Conduct interviews for acceptance into the program
- Attend monthly check-in meeting

Payment: \$25 per hour for administrative, which includes interviews, tracking assignments, attending webinars, monthly check-in meeting. \$100 per hour for supervision, plus CE Certificate for classes. SPT Membership free during duration of this contract.
